

HARTWIG MEDICAL FOUNDATION - PUBLICATION POLICY

Version: 3.0

This publication policy applies from 1 March 2019.

1. This publication policy applies to any publication (“**Publication**”) that is based on, involves and/or mentions data (“**Data**”) obtained from the database of Stichting Hartwig Medical Foundation (“**Database**”) and/or statistical information (“**Statistical Information**”) based on Data in the Database.
2. Any person and/or entity (a “**Licensee**”) that is allowed access to any Data from the Database and/or has obtained Statistical Information, shall comply with this publication policy regarding any publication that is based on, involves and/or mentions Data or Statistical Information.
3. Licensee shall ensure that Hartwig Medical Foundation is acknowledged in any Publication as the entity from which the Data and/or the Statistical Information has been obtained by using the following text:

This publication and the underlying study have been made possible partly on the basis of the data that Hartwig Medical Foundation has made available to the study.

In case the Data have been generated using material/data collected in the context of one of the studies performed by the Center of Personalized Cancer Treatment (CPCT), which will be indicated to you by us, the following text shall be used:

This publication and the underlying study have been made possible partly on the basis of the data that Hartwig Medical Foundation and the Center of Personalised Cancer Treatment (CPCT) have made available to the study.

4. Licensee acknowledges that the Database and Data contain data obtained from third party medical institutions/centers and/or research performed by third parties. In case the Licensee obtained access to the Data from the Database in the context of a research aimed at discovery, Licensee agrees to acknowledge the contribution of these third parties in the following manner:
 - a. In the event that >5% of the Data provided to Licensee consists of data from a specific third party, such third party shall have the right to appoint one author to be mentioned as co-author in any publication made by Licensee regarding or in connection with the Data;
 - b. In the event that >20% of the Data provided to Licensee consists of data from a specific third party, such third party shall have the right to appoint two authors to be mentioned as co-author in any publication made by Licensee regarding or in connection with the Data.

The percentage of Data originating from a third party within the meaning of this clause, shall be calculated on the basis of the number of patients of whom personal data provided by such third party have been included in the Data, set off against the total number of patients of whom personal data are included in the Data. In the event that multiple third parties have a share in the Data, the rules on co-authorship set forth in this clause shall apply to each separate third party.

5. In case the Licensee obtained access to the Data from the Database in the context of a research

aimed at independent validation of discoveries from previous researches, Licensee shall mention CPCT as a co-author in any publication made by Licensee regarding or in connection with the Data in the following manner: *author: Center for Personalized Cancer Treatment; affiliation: CPCT consortium, Rotterdam, The Netherlands.*

6. In case of disagreement on the qualification of a research aimed at discovery (as provided for in article 4 hereof) or validation (as provided for in article 5 hereof) between Hartwig Medical Foundation and the Licensee, Hartwig Medical Foundation's opinion shall be decisive.
7. Licensee shall comply with the recognized ethical standards concerning publications and authorship, including the Uniform Requirements for manuscripts submitted to Biomedical Journals, established by the International Committee of Medical Journal Editors.
8. Licensee shall provide Hartwig Medical Foundation with a copy of any Publication within two (2) weeks after the actual publication.
9. This publication policy may be amended from time to time. The updated version of the publication policy will be applicable to any Publication that has not yet been submitted for publication on the date on which the updated publication policy is first published on Hartwig Medical Foundation's website.
